NEW DISCOVERIES IN WATER ICICLE

The following message from the Orpheus C. C. Digging Team who made the discoveries has been posted on UKcaving.com:

Many cavers will have seen the recent article in Descent of the breakthrough in Water Icicle and will be eager to have a look at the extension. Could we please remind people that at present access to the extension is for digging and conservation only. The ladder in North West choke has currently been removed for safety reasons and to allow time for permanent conservation taping. A small amount of time spent now will hopefully save the delicate features for many years to come. Full access will be announced as soon as conservation work and a safe means of entry are completed. Obviously this does not affect access to the rest of the known system. Thanks for your patience.

CLEAN UP IN STONEY MIDDLETON DALE

ARROWS IN CARLSWARK

Spray-painted arrows have reappeared in Carlswark but, despite enquiries, it is still not known who is responsible. Darkside members will be removing them. It was agreed to publicise this and to ask cavers' help in tracking down the culprits. Notices will be placed inside entrances (Eyam Dale Shaft, & Gin) to draw attention to the fact that this is an illegal activity in an SSSI and Natural England has the power to prosecute.

LOOSE ROCK IN SUICIDE CAVE, WINNATS PASS

There have been a couple of recent independent reports about the stability of blocks at the top of the biggest pitch in Suicide Cave in the Winnats Pass: the pitch which needs a 30m rope. There are a number of blocks on the right-hand wall just before the final Y Hang with fresh-ish cracks, so keep your eyes open in this area.
